That OTSG is now operating at a higher firing rate and maintaining steam quality and capacity, with NOx emissions reduced to less than 5 parts per million (PPM).

"This commercial order marks an inflection point in ClearSign's growth, underscoring the unique environmental and economic benefits of our technology," said ClearSign Chairman and CEO, Steve Pirnat. "This strong entry into the upstream oil and gas market presents a significant opportunity for ClearSign, and we look forward to working with Aera and other companies in the EOR space on this, and future, projects."
